TENTATIVE RUNNING ORDER:

- Instinct will run prior to Novice
- Running order will be established after the pre-entry closing date and will be in the final confirmation letter

AWARDS: Placement ribbons will be awarded for first through fourth place in Novice, Open, Senior & Master classes in each height division. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. New Title Rosettes will be available for Novice, Open Senior & Master Titles. Flat New Title Ribbons for Instinct.

These trials will be held indoors. There will be crating space available inside the building but please make sure your crate is secure as the dogs may be highly excited. Please bring adequate water and shade for you and your dogs if you plan to crate out of your vehicle.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the pre-entry period for the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge's briefing.

Entry Fees:

\$10 Instinct (Instinct is only offered on Trial 1 of each day)

\$20 Novice , Open & Crazy 8

\$25 Senior

\$30 Master

Fees after pre-entry closing of date and for day of show:

\$15 Instinct

\$25 for Novice/Open/Crazy 8

\$30 for Senior

\$35 for Master

All checks will be cashed upon receipt. No refunds after pre-entry closing date except for injured dogs with vet proof. \$10 administrative fee will be charged.

Directions to show site:

I-83 to Exit 32 (Newberrytown Exit-old exit #13), Take Rt. 382 North to Lewisberry, approximately 3 miles to flashing traffic light. Turn left, on South Rt. 177 toward Rossville, travel approximately 3 miles. Turn right on Mt. Airy Rd. (across from Lake Pinchot Park Office) and continue 1.7 miles to site on left.

RT. 15 to Mechanicsburg-Bowmansdale Exit, Rt. 114 towards Ski Roundtop, At the split, DO NOT FOLLOW 114, continue straight on North York Road. Turn left on East Mt. Airy Rd (at Mt. Pleasant Church of God), past Ski Roundtop (on right) and continue to "T" intersection. Turn right on Pinetown Road, then take first left on Mt. Airy Road. Site is immediately on the right.
