Directions:

I-83 to Exit 32 (Newberrytown exit). At the light at the bottom of the ramp, turn left onto Rt. 382 North to Lewisberry. Go approximately 3 miles to the flashing traffic light and turn left onto Rt. 177 South toward Rossville. Go approximately 3 miles and turn right on Mt. Airy Rd. (across from Lake Pinchot Park Office). Continue approximately 1.7 miles to the site on the left.

US-15 to Mechanicsburg and take the Bowmansdale exit, Rt. 114 towards Ski Roundtop, At the traffic light at the bottom of the hill, proceed straight on South Market Street. DO NOT FOLLOW 114. Continue straight about 2.3 miles on South Market St. which will become North York Rd. Turn left on East Mt. Airy Rd (at Mt. Pleasant Church of God) and go approximately 4.5 miles. You will pass Ski Roundtop on the right. Continue to a "T" intersection and turn right on Pinetown Rd. Take the first Left onto Mt. Airy Road. Site is immediately on the right.

If your dog earns an obedience or rally title after you have completed this entry and submitted it, you must notify the Trial Secretary immediately.

General Information

- These will be indoor trials on rubber matting.
- Building is climate controlled. Indoor crating space is available but limited.
- There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to the pre-entry closing date and can be filled by the waiting list. A \$10 administrative fee will be charge for all refunds. 50% refunds will be made for bitches in season with vet proof.

GENERAL AGREEMENT

I (we) agree that Bella Vista Training Center, the hosting club, has the right to refuse this entry for any cause which the organizing committee alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, Bella Vista Training Center, Golden Rule School for Dogs (CDSP), including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

I (we) further acknowledge that I (we) have read, understand, and will abide by the Official Rules and Regulations of Companion Dog Sports Program and the provisions for entry as set forth in the Trial Schedule of which this entry form is a part. I (we) acknowledge and represent that the information supplied by me (us) herein is correct to the best of my (our) knowledge; if any portion of this information is found to be invalid or insufficient to establish the validity of my (our) entry, such finding shall render my (our) entry invalid in its entirety, for which there shall be no refund of fees paid. Further, I (we) represent that I am (we are) the owner(s) of the dog listed hereon, or that I (we) am (are) a family member of the dog's owner as stated and allowed in the CDSP rules, and that I (we) shall hold the hosting club and CDSP, including their officers, directors, employees and agents and their sponsors, harmless from any liability or claim made by dog's owner.

Further, I (we) hereby grant to the hosting club, CDSP, their representatives, agents, and assigns, all rights and permissions to use or appropriate my and the dog's name, biography, likeness, photograph, voice, performing persona, or other indicia or identity for broadcast, telecast, cablecast, transmission, or distribution in any format or media now known or hereafter to become known. I (we) hereby release CDSP, the hosting club, their representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of personality, or any similar right.
