TENTATIVE RUNNING ORDER:

- Instinct will run prior to Novice
- Running order will be established after the pre-entry closing date and will be in the final confirmation letter

AWARDS: Placement ribbons will be awarded for first through fourth place in Novice, Open, Senior & Master classes in each height division. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. New Title Rosettes will be available for Novice, Open Senior & Master Titles. Flat New Title Ribbons are available for the Instinct Class.

These trials will be held indoors. There will be crating space available inside the arena but please make sure your crate is secure as the dogs may be highly excited. You are required to place a tarp under your crate. Please bring adequate water and shade for you and your dogs if you plan to crate out of your vehicle. Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the pre-entry period for the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge's briefing.
