<u>Crating Areas</u>: Crating in Annex is limited to BVTC Employees, Committee members and handicapped individuals. <u>Clean</u> tarps are required under all crates. Chairs may be placed in the Annex crating area. If you choose to bring fans or other devices, they must be battery operated. Please be considerate of others by keeping your crating area neat and monitor your dog's behavior. Disruptive/reactive dogs may be asked to be crated in vehicles or make other arrangements. No grooming in the Annex. <u>Maximum of 25 people in the Annex</u>

Seating Area: Maximum of 25 people in The Arena area

Outdoor Areas: Please remember that this is an AKC event and dogs are NOT permitted to be off leash on any part of the show grounds except at the practice jump and in the ring. Please clean up after your dogs. If you fail to clean up after your dog, you will be assessed a \$50 fine. Failure to pay or repeated offenses will result in you being asked to immediately leave the property. Flexi-leashes may not be used in the building or within 50 feet of the building as per BVTC policy. Dogs and Individuals are NOT permitted behind the left side back edge of the Arena or the right front edge of the Annex at any time! Anyone found in these areas will be asked to immediately leave the property. Dogs may be walked to left of the kennel but not past the back side of the arena. DOGS ARE NOT ALLOWED ON ADJOINING PROPERTIES!
