Setup: No General setup.

Emergency Policy: If a serious weather concern exists, please call BVTC's main number at 717-432-0750 and listen to the message. The message will be updated at 5:00 AM if a delay/cancellation will occur. **Emergency Numbers during the trial are 717-542-0427 or 717-515-5146**

Directions: Directions to the facility are located on the website at www.BVTrainingCenter.com

Food: Allen's Eatery in Lewisberry will provide lunch delivery service. The menu will be posted in the arena. Orders must be placed by 10:30 AM, and they will be delivered by 11:30 AM.

Volunteers: A sign up board will be available at the trial. Please volunteer early and often! Raffle prizes and coupons will be awarded to workers. Coupons may be used at any vendor or for future BVTC events!

Crating Areas: Clean tarps are required under all crates. Chairs may be placed in the Annex crating area. If you choose to bring fans or other devices, they must be battery operated. Please be considerate of others by keeping your crating area neat and monitor your dog's behavior. Disruptive/reactive dogs may be asked to be crated in vehicles or make other arrangements. No grooming in the Annex. Maximum of 25 people in the Annex at any time!

Seating Area: **Maximum of 25 people in arena!**

Outdoor Areas: Please remember that this is an AKC event and dogs are NOT permitted to be off leash on any part of the show grounds except at the practice jump and in the ring. Please clean up after your dogs. If you fail to clean up after your dog, you will be assessed a \$50 fine. Failure to pay or repeated offenses will result in you being asked to immediately leave the property. Flexi-leashes may not be used in the building or within 50 feet of the building as per BVTC policy. Dogs and Individuals are NOT permitted behind the left side back edge of the Arena or the right front edge of the Annex at any time! Anyone found in these areas will be asked to immediately leave the property. Dogs may be walked to left of the kennel but not past the back side of the arena. **DOGS ARE NOT ALLOWED ON ADJOINING PROPERTIES!**

Trial Secretary: The Trial Secretary area will be in the Arena. The Trial Secretary will be on site at 7:15 AM to handle any questions/concerns. Email TrialSec@BVTrainingCenter.com with all move ups or entry questions. Day to day move ups are due by the end of the trial day. A move up book is provided at the Secretary's desk.

Restrooms: Both restrooms are accessible only off the Kennel porch area. Please do not enter the Kennel office. Please do not put anything but toilet paper in the toilets! Please put other items in the trashcans.

No Smoking: No smoking in any building, including bathrooms! No smoking within 20 feet of all buildings. Please properly dispose of all butts.

Measuring: All dogs needing measurements are required to be measured prior to their run. Measuring will be done in the Arena. There will be a VMO at this trial.

You may get a text back asking your name, or date of birth or if you are a Parent, Teacher or Student.

You can type in your name, or your dog's name(s), or anything you want if you choose to.

Please note: The messages will not come thru the 81010 but will come from a random number – so check your text messages. If you had already signed up for AKC text message notices you will probably not be asked any questions.

Please note the running order for Exc/Mas classes. Walk-thrus will be 7 minutes. Any groups over 25 will be split. Groups under 25 will 5 mins to first dog.
