**Setup:** There will be no general setup on Wednesday

**Food:** Allen's Eatery in Lewisberry will provide lunch delivery service. The menu will be posted in the arena. Orders must be placed by 10:30 AM, and they will be delivered by 11:30 AM

**Volunteers:** A sign up board will be available at the trial. Please volunteer early and often! Raffle prizes and coupons will be awarded to workers. Coupons may be used at any vendor or for future BVTC events!

**Crating Areas:** There will be crating in the Annex. Clean tarps are required under all crates. If you choose to bring fans or other devices, they must be battery operated. Please be considerate of others by keeping your crating area neat and monitor your dog's behavior. Disruptive dogs may have to be crated in vehicles or make other arrangements. Personal chairs allowed in crating area. No grooming in the Annex.

**Seating Area:** There will be designated seating in the Arena. No outside chairs are allowed in seating area.

**Outdoor Areas:** Please remember that this is an AKC event and dogs are NOT permitted to be off leash on any part of the show grounds except at the practice jump and in the ring. Please clean up after your dogs. If you fail to clean up after your dog, you will be assessed a \$50 fine. Failure to pay or repeated offenses will result in you being asked to immediately leave the property. Flexi-leashes may not be used in the building or within 50 feet of the building as per BVTC policy. Dogs and Individuals are NOT permitted behind the left side back edge of the Arena or the right front edge of the Annex at any time! Anyone found in these areas will be asked to immediately leave the property. Dogs may be walked to left of the kennel but not past the back side of the arena. **DOGS ARE NOT ALLOWED ON ADJOINING PROPERTIES!**

**RV/Oversized Vehicles/Trailer Parking:** BVTC has 10 RV spots with 30amp and 50amp hook-ups. Reservations are required. The reservation form is located on our website at [www.BVTrainingCenter.com](http://www.BVTrainingCenter.com). Class "B" type vehicles are allowed with pre-approval. Additional 30 amp or 20 amp hookups are available for Class B vehicles for \$10 per day. No trailers are allowed unless prior arrangements are made. **Restrooms:** Both restrooms are accessible only off the Kennel porch area. Please do not enter the Kennel office. Please do not put anything but toilet paper in the toilets! Please put other items in the trashcans.

**No Smoking:** No smoking in any building, including bathrooms! No smoking within 20 feet of all buildings. Please properly dispose of all butts.

**Measuring:** All dogs needing measurements are required to be measured prior to their run. Measuring will be done in the Arena. There will be a VMO at this trial.
